SUBJECT: DECLARATION AS DRUG-CLEARED CONTROLLED FACILITY

WHEREAS, the proliferation of illegal drugs and drug-related incidents has been constantly posing serious threat to the health, peace and order of communities even in controlled facilities for Persons Deprived of Liberty (PDLs);

WHEREAS, in consonance with the strong pronouncement of the President to immediately address the country's drug problem, there is an urgency to strengthen our strategies in addressing the drug situation in all controlled facilities for PDLs nationwide;

WHEREAS, pursuant to Dangerous Drugs Board Regulation No. 2, Series of 2020 which provides for the Guidelines in the Nationwide Implementation of Drug Clearing Program in Controlled Facilities for PDLs, the Oversight Committee is created to evaluate and verify all the necessary information/documents submitted by the subject applicant and hereby issued this resolution and certification for such declaration;

WHEREAS, once issued with corresponding declaration, the Head of the Controlled Facility is duty bound to ensure that the facility is maintained to be drug-cleared subject to quarterly validation of the Oversight Committee;

WHEREAS, appurtenant thereto, the Oversight Committee is likewise empowered to issue an automatic revocation of its declaration, if the subject applicant upon validation fails to maintain the status of the declaration;

NOW, THEREFORE, after due deliberation and upon complete evaluation of the required documents submitted in compliance to the parameters set forth under **Section 13, Paragraph (1)** of the **Dangerous Drugs Board Regulation No. 2 Series of 2020**, and approved by all the members of the Committee, do hereby **RESOLVE** to declare (Complete Name of Jail and Address) as a **DRUG-CLEARED** Controlled Facility for Persons Deprived of Liberty effective (Month/Day/Year).
