BOARD RESOLUTION NO. 3
Series of 2017

SUBJECT: APPROVING THE PROVISION OF FINANCIAL ASSISTANCE FROM THE SPECIAL ACCOUNT IN THE GENERAL FUND OF THE BOARD TO GOVERNMENT TREATMENT AND REHABILITATION CENTERS AND COMMUNITY-BASED TREATMENT AND REHABILITATION FACILITIES FOR CY 2017

WHEREAS, Section 75 of Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002 provides that the Board shall support the establishment of government-operated regional treatment and rehabilitation centers and shall give priority funding for the increase of subsidy to existing government drug rehabilitation centers;

WHEREAS, Section 87 of the Implementing Rules and Regulations of the same law provides for the creation of a Special Account in the General Fund (SAGF) in favor of the Board;

WHEREAS, the aforesaid provision also provides funding for assistance to drug treatment and rehabilitation centers owned and operated by the National Government and its political subdivisions, including establishment and maintenance of new drug treatment and rehabilitation centers in the country as well as the operation and maintenance of existing ones;

WHEREAS, to complement the ongoing campaign against illegal drugs of President Rodrigo Roa Duterte, the Board issued Regulation No. 4, Series of 2016 calling for the implementation of community-based treatment and rehabilitation programs in local government units in order to introduce appropriate interventions to individuals who have low to mild substance use disorder;

WHEREAS, the Treatment and Rehabilitation Centers (TRC) Committee of the Board, with the Department of Health as Chairperson and pursuant to the Internal Rules of the Board, shall deal with requests for assistance concerning the establishment, putting up, construction, repair and maintenance of treatment and rehabilitation facilities in the country;

WHEREAS, the TRC Committee has recommended approval of release of financial assistance from the SAGF for the benefit of selected government in-patient and community-based treatment and rehabilitation centers which requested such assistance.

WHEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, that the Dangerous Drugs Board approves the recommendation of the Treatment and Rehabilitation Centers Committee of the Board and authorizes the provision of financial
