**DANGEROUS DRUGS BOARD**

**BOARD RESOLUTION NO. 6  
Series of 2020**

**SUBJECT: APPROVING THE PROVISION OF FINANCIAL ASSISTANCE FROM THE SPECIAL ACCOUNT IN THE GENERAL FUND OF THE BOARD TO GOVERNMENT TREATMENT AND REHABILITATION CENTERS AND COMMUNITY-BASED TREATMENT AND REHABILITATION FACILITIES FOR CY 2020**

**WHEREAS**, Section 75 of Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002, as amended, provides among others, that the Dangerous Drugs Board (the “Board”) shall support the establishment of government – operated regional treatment and rehabilitation centers and shall give priority funding for the increase of subsidy to existing government drug rehabilitation centers;

**WHEREAS**, Section 87 of the Implementing Rules and Regulations of the same law provides among others, for the creation of a Special Account in the General Fund (SAGF) in favor of the Board;

**WHEREAS**, the aforesaid provision provides among others, funding assistance to drug treatment and rehabilitation centers owned and operated by the National Government and its political subdivisions, including establishment and maintenance of new drug treatment and rehabilitation centers in the country as well as the operation and maintenance of existing ones;

**WHEREAS**, the Philippine Anti – Illegal Drugs Strategy, in relation to Regulation No. 7, Series of 2019 issued by the Board, calls for the implementation of community – based treatment and rehabilitation programs in local government units in order to introduce appropriate interventions to individuals who have low to moderate risk of drug use;

**WHEREAS**, the Treatment, Rehabilitation, and Reintegration Committee of the Board (the “Committee”), with the Department of Health as Chairperson, deals with requests for assistance concerning the establishment, putting up, construction, repair and maintenance of treatment and rehabilitation facilities in the country;

**WHEREAS**, the Committee has recommended approval of release of financial assistance, to be taken from funds collected from remaining balances and unused funds from previous recipients of funding support from the Board, amounting to Php 21.43 Million, to the following rehabilitation facilities that have requested for such assistance:

**WHEREFORE**, be it **RESOLVED**, as it is hereby **RESOLVED**, that the Dangerous Drugs Board approve the recommendation of the Treatment, Rehabilitation, and Reintegration Committee of the Board and authorize the provision of financial assistance to government treatment and rehabilitation centers and community-based treatment and rehabilitation facilities in the amounts as listed above.
