**BOARD RESOLUTION NO. 17
Series of 2021**

SUBJECT: REAPPOINTMENT OF MR. MARTIN Y. PARAGOSO AND MR. EFREN LAVIÑA AS MEMBERS OF OPERATION: “PRIVATE EYE” REWARD COMMITTEE REPRESENTING THE BUSINESS SECTOR

WHEREAS, Section 2 of RA 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002, as amended, states, among others, that “it is the policy of the State to safeguard the integrity of its territory and the well-being of its citizenry particularly the youth, from the harmful effects of dangerous drugs on their physical and mental well-being, and to defend the same against acts of omissions detrimental to their development and preservation”;

WHEREAS, the same law also mandates the Board, as its policy-making and strategy-formulating body, to issue and promulgate such rules and regulations necessary to carry out and implement its provisions;

WHEREAS, the Board in 2003 issued Regulation No. 5, Series of 2003, entitled “Guidelines in the Implementation of Operation: “Private Eye,” which is a citizen-based program in the collection of information on illegal drug activities;

WHEREAS, Section 2, Article II of the said Regulation provides for the creation of the Operation: “Private Eye” Reward Committee which shall deliberate on claims for rewards and grant the appropriate monetary rewards to qualified informants, the composition of which includes, among others, two (2) representatives from the Business Sector;

WHEREAS, the same provision of the said Regulation further states that the Board “shall appoint men and women of proven integrity and probity from the business, religious and academe sectors as members of the Committee”;

WHEREAS, during the 195th Regular Meeting of the Board (9th Special Online Session), held on 8 November 2021, the DDB Supply Reduction Committee (SRC) recommended the reappointment of Mr. MARTIN Y. PARAGOSO and Mr. EFREN LAVIÑA as members of the Operation: “Private Eye” Reward Committee representing the Business Sector.

WHEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, to approve the recommendation for reappointment of MR. MARTIN Y. PARAGOSO and MR. EFREN LAVIÑA as members of the Operation: "Private Eye" Reward Committee representing the Business Sector.
