**FAILURE OF BIDDING FOR THE UPDATE AND MAINTENANCE OF
SERVER COMPONENT FOR MANAGEMENT INFORMATION
SYSTEM UNIT OF DANGEROUS DRUGS BOARD**

WHEREAS, in compliance with the provisions of RA No. 9184 (Government Procurement Reform Act), the DDB Bids and Awards Committee has caused the release and posting of an Invitation to Bid on 18 September 2020 for the Update and Maintenance of Server Component for Management Information System Unit of Dangerous Drugs Board with an Approved Budget for the Contract (ABC) of Five Million Pesos (Php 5,000,000.00)

WHEREAS, during the scheduled date of Opening of Bids on 12 October 2020, the Committee was informed that no one bought the bid documents;

WHEREAS, this prompted the BAC members to declare the said bidding as failure;

WHEREFORE, be it **RESOLVED**, as it is hereby **RESOLVED**, that after review and evaluation, and upon recommendation of the Committee Secretariat, the Committee declares a **failure of bidding** for the Update and Maintenance of Server Component for Management Information System Unit of Dangerous Drugs Board;

RESOLVED further, that there be an immediate reposting by the Committee Secretariat in the Invitation to Bid (ITB) with PhilGeps.
